However, all the issues are left open to be raised before the Court below. Considering the submission made, personal appearance of the petitioner before the Court below is dispensed with until and unless the same is required. The learned Judicial Magistrate No.III, Tirunelveli is directed to dispose of P.R.C.No.16 of 2013 within a period of six months from the date of receipt of a copy of this order.
