3. when the matter is taken up for hearing, the learned Government Advocate (Crl.side) would submit that in pursuant to the investigation, came to know that the persons mentioned by the petitioner have played a role in the alleged occurrence and they have been arrayed as accused. At the time of filing of the report there is a likelihood of the petitioner mentioned persons are being arrayed as accused.

4. In view of the submission made by the learned Government Advocate (Crl.side), the criminal original petition is closed. The respondents are directed to file a final report within a period of three months from the date of receipt of a copy of this order.
