2.The case of the petitioner is that the petitioner is the owner of the land in Survey No.26/3B-1A measuring 52 cents in Korampallam Village and that some miscreants were consuming liquor and thereafter, bottles were littered on his vacant land. In this regard, the petitioner seems to have given a representation to the respondent police on 12.04.2015 for taking appropriate action.
