The petitioner has sought transfer of investigation in Crime No.56 of 2014 pending on the file of the third respondent to any other competent Officer.

2. The main ground on which the transfer is sought for by the petitioner is that the (*)**second** respondent is personally close to the accused person.

Though this Court is not willing to go into the said allegation, considering the fact that the allegation made the petitioner to lose faith in the investigation conducted by the (*)**second** respondent, without going into the merits, a direction is issued to the first respondent to transfer the investigation in Crime No.56 of 2014 pending on the file of the (*)**second** respondent to any other investigating agency/competent officer. The first respondent is further directed to monitor the investigation.

This Criminal Original Petition is ordered accordingly.
