Prayer in CRL OP(MD) No.16442 of 2014:

to pass an order of direction, directing the 2nd respondent police to register a case based on the complaint of the petitioner dated 15.08.2014 and investigate the same in accordance with law.

Prayer in CRL OP(MD) No.16610 of 2014:

to direct the 2nd respondent herein to register a case on the basis of the complaint preferred by the petitioner dated 14/08/2014.

Prayer in CRL OP(MD) No.18227 of 2014:

to direct the 1st Respondent to direct the 3rd respondent to register the case against the accused and investigate the same in accordance with law on the basis of the petitioner's complaint dated 18/12/2013.
