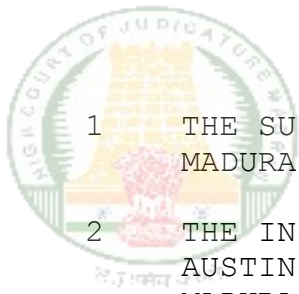

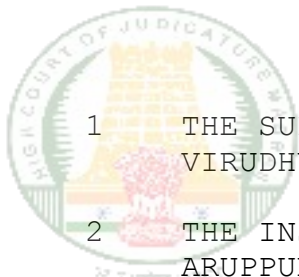

Prayer in CRL OP(MD) No.10136 of 2015:

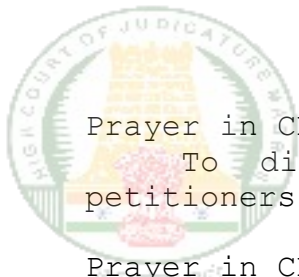
To direct the 2nd respondent to register the petitioners complaint dated 28.05.2015 within the period stipulated by this Hon'ble Court.

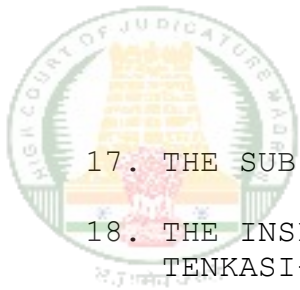
