Prayer: Criminal Revision Petition filed under Section 397 r/w 401 Cr.P.C., against the judgment dated 27.06.2014 in C.A.No.29 of 2014 passed by the Sessions Judge, Tiruchirappalli, confirming the conviction and sentence passed by the trial Court, i.e, Judicial Magistrate, Manapparai, on 04.03.2014 in S.T.C.No.798 of 2012.

ORDER

The revision petitioner is the accused in S.T.C.No.798 of 2012 on the file of the learned Judicial Magistrate, Manapparai. The learned Magistrate, by judgment dated 04.03.2014, has convicted him under Section 138 of the Negotiable Instruments Act and sentenced him to undergo rigorous imprisonment for one year and a fine of Rs.5,000/-, in default, to undergo simple imprisonment for two months. As against the same, he filed an appeal in C.A.No.29 of 2014 before the Principal Sessions Judge, Tiruchirappalli. By judgment dated 27.06.2014, the lower appellate Court dismissed the appeal, thereby confirming the conviction and sentence imposed on the petitioner. Challenging the same, the petitioner has come
