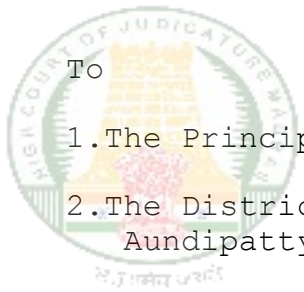
Order : This petition coming on for orders on this day, the court made the following order:-

Earlier, this Court on 27.08.2015 in Crl.R.C.(MD)No.373 of 2015 filed by the Petitioner, had directed the Learned Judicial Magistrate, Aundipatti to dispose of M.C.No.4 of 2014 within a period of one month from the date of receipt of a copy of this order.

2.It comes to be known that the Learned District Munsif-cum-Judicial Magistrate, Theni in D.No.4499/15, dated 23.11.2015, had addressed a letter to the Registrar(Admn.), Madurai Bench of Madras High Court, Madurai, inter-alia, stating that M.C.No.4 of 2014, pending on his file was in Part-Heard stage and also that on the side of the respondents, witnesses were to be examined and that the original time granted by this Court had expired on 09.11.2015 and sought for further extension of two months time to dispose of M.C.No.4 of 2014, pending on his file.
