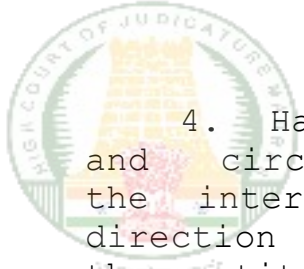

ORDER

Invoking the provisions of Article 227 of the Constitution of India, the petitioners have approached this Court with this Civil Revision Petition, seeking a direction to the learned District Munsif, Thirumangalam to dispose of E.P.No.17 of 2015 in R.C.O.P.No.10 of 1998 on the file of the Rent Controller (District Munsif Court), Thirumangalam as expeditiously as possible preferably within a time, which may be fixed by this Court.

2. Heard Mr.C.Vakeeswaran, learned counsel appearing for the petitioners and perused the averments of the grounds of the Civil Revision Petition.

It appears that the revision petitioners herein, who are the petitioners, have filed E.P.No.17 of 2015 in R.C.O.P.No.10 of 1998 on the file of the Rent Controller (District Munsif Court), Thirumangalam, and the same had been unnecessarily and periodically adjourned without assigning any valid reason and since the petitioners have approached this Court by way of this Civil Revision Petition.



4. Having been taken into consideration of the related facts and circumstances, this Court is of view that in the interest of Justice it may be expedient to issue a direction to the executing Court, as sought for by the petitioner.
