ORDER

It appears that the revision petitioner herein, who is the petitioner, has filed E.A.No.204 of 2015 in E.P.No.41 of 2015 in R.C.O.P.No.74 of 2014 and the same had been unnecessarily and periodically adjourned without assigning any valid reason and therefore, the petitioner has approached this Court by way of this Civil Revision Petition.
