ORDER

[Order of the Court was made by S.NAGAMUTHU,J]

The petitioner is the husband of one Illakiya, D/o.Rengasamy, aged about 24 years. She is an M.B.A. Graduate. According to the petitioner, she has been illegally detained by somebody.

2.Today, when the matter was taken up, the petitioner was not present, neither was there any representation for him. The detenu has been produced by the second respondent. The detenu, on enquiry, stated that she has not been detained by anybody and she has been all along with her parents. She has filed a case of divorce also against the petitioner. The said submission is recorded. She wants to go back with her parents and her parents also present before this Court.
