The Petitioner has come up with this petition alleging that his wife Chitra, aged about 29 years and his son Sabarinathan, aged about 6 months old child, are illegally detained by the respondents 4 to 7. The records reveal that the complaint has been made only on 04.09.2015.



2. The learned Additional Public Prosecutor would submit that the respondent police is taking steps to locate both of the detainee and her son and they need breathing time to make further investigation.
