2. Today, Minor - Sahaya Monica, D/o.Mohan Dasan, aged about 17 years, has been produced by her mother, the petitioner herein. Sahaya Monica states that she went with the third respondent - Jose and because of the case registered, he himself volunteered to take her and leave her at her parental home.

3. AS the alleged detenu has been now brought under the custody of her mother, namely the petitioner herein, we allow the



petitioner to take her along with her and close the Habeas Corpus Petition with a direction to the police to proceed with the criminal case registered against the third respondent.
