ORDER

This Habeas Corpus Petition has been filed under Article 226 of the Constitution of India praying to direct the respondents 1 & 2 to trace out and produce the detenu by name Shilpa @ Selvi, alleged wife of the petitioner.

2. The petitioner is present and he has been identified by his counsel.

3. The second respondent viz., the Inspector of Police, All Women Police Station, Tenkasi has produced the first wife of the petitioner by name Jeyachitra and she has been enquired into and stated that the marriage between her and petitioner is still subsisting.
