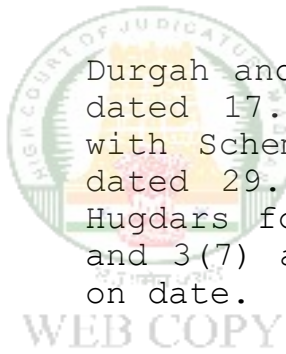

PRAYER IN CONT.P. (MD)No.SR47286 of 2014 : To punish the Respondents for committing contempt of court by violating the direction of this Hon'ble Court dated 17.07.2014 passed in Contempt Petition(MD)No.447 of 2013 in WP(MD)No.14946 of 2012.

PRAYER IN CONT.P. (MD)No.447 of 2013: Petition filed under Section 11 of Contempt of the Contempt of Courts Act, to issue a summons to the Respondent/Contemnor herein and punish him for committing contempt of Court by violating the direction of this Court in W.P(MD) No.14946 of 2012 dated 23.11.2012.

PRAYER IN WP(MD).No.14946 of 2012 : Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus, directing the 1st Respondent namely the Wakf Board to appoint five members committee to manage the Begampur



Durgah and Mosque Pallivasal as per the order of the 1st Respondent dated 17.03.2003 passed in Rc.5142/2002/C4/DGL and in consonance with Scheme framed by the Ramnad Sub Court in O.S N. 49 of 1914 dated 29.01.1917 and to pay the benefits to the Beneficiaries / Hugdars for rendering their service as defined under Sections 3(A) and 3(7) and 3(29) of the Wakf Act for the periods from 1954 to as on date.
