This Habeas Corpus Petition has been filed under Article 226 of the Constitution of India praying to direct the respondents 1 and 2 to trace out and produce the detenu by name Rajameenakshi, aged 25 years, wife of the petitioner.



2. The petitioner is not present, whereas his counsel is present.

3. The first respondent viz., Inspector of Police, Munneerpallam Police Station, Tirunelveli District has produced the detenu.

4. The parents of the detenu viz., respondents 3 and 4 are present. The detenu has been secured and she stated that she is living in the house of their parents.

5. Considering the aforesaid factual circumstances, the relief sought for in the Habeas Corpus Petition has become infructuous.

6. In fine, this Habeas Corpus Petition is dismissed.
