The petitioner is present and he has been identified by his counsel.

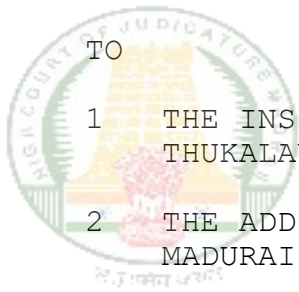
The detenu has been produced and she expressed her willingness to go with the petitioner.
