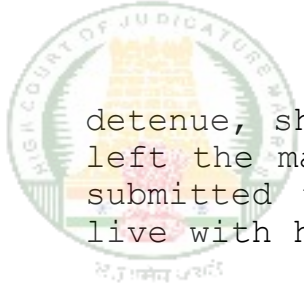
ORDER

2. Alleging illegal detention, writ of Habeas Corpus is sought for.

3.On notice, the Inspector of Police, Colachel Police Station, Kanyakumari District has produced the alleged detainees. When we enquired Selvi, wife of the petitioner and the alleged



detenue, she submitted that there was a wordy quarrel and hence, she left the matrimonial home, along with her two children. She further submitted that she wants to go back to her matrimonial home, and live with her husband.

4. In view of the above, this Habeas Corpus Petition is dismissed. The Inspector of Police, Colachel Police Station, Kanyakumari District is directed to give proper advice to them.
