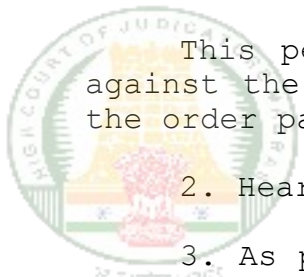
PRAYER IN CONT.P(MD)NO.SR55041 OF 2014 :

To issue notice to respondents 2 and 3 and punish them for willful disobedience of the order passed in WP(MD)No.4473 of 2012 dated 22.04.2014.

PRAYER IN WP(MD)NO.4473 OF 2012 :

Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Mandamus to direct the respondents to pay the amount Rs.1,34,231/-, which was deducted from out of the contribution made by the petitioner to the employees Provident fund, which is in violation of section 78(2)(c) of the Tamil Nadu Cooperative Societies Act.

ORDER : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.V.CHANDRASEKAR, Advocate for the petitioner the court made the following order:-



This petition is filed to grant leave to the petitioner to proceed against the first respondent also and punish him willful disobedience of the order passed in WP(MD)No.4473 of 2012 dated 22.04.2014.
