The delay in representing the Contempt Petition is condoned on payment of cost of Rs.500/- (Rupees Five hundred only) payable to the Chief Justice Relief Fund to be forwarded to the persons who affected in Nepal Earthquake Tragedy. The said amount shall be paid within a period of three weeks from today.
