Prayer in WP(MD). 14161/ 2013 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus, directing the Respondents from 1 to 3, to Count the half of the service rendered by the petitioner as a social forestry worker from 01.04.1986 to 06.08.2009 along with the regular service as Plot Watcher from 07.08.2009 to 30.06.10 as a qualifying service and send the revised pension proposal to the 4th Respondent and to further direct the 4th Respondent to sanction the eligible pension and all other terminal benefits to the petitioner and pass such further or other orders as this Honble Court.

Prayer in WP(MD). 14163/ 2013 :

Writ Petition is filed under Article 226 of the Constitution of India, praying this Court To issue a Writ of Mandamus, directing the Respondents from 1 to 3, to Count the half of the service rendered by the petitioner as a social forestry worker from 01.05.1984 to 06.08.2009 along with the regular service as Plot Watcher from 07.08.2009 to 28.02.2010 as a qualifying service and send the revised pension proposal to the 4th Respondent and to further direct the 4th Respondent to sanction the eligible pension and all other terminal benefits to the petitioner and pass such further or other orders as this Honble Court.
