(Judgment of this Court was delivered by S.MANIKUMAR,J.)

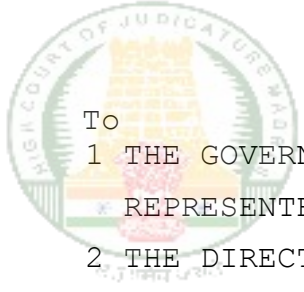
