ORDER

The petitioner has come forward with this Writ Petition to measure the property and fix the boundary, for the lands possessed by her.

At the time placing arguments, the learned counsel appearing for the petitioner has specifically averred that the property situated in S.No.133/1A at marikundu Village, Rethimmakkal Patti, Andipatti Taluk, Theni District, belongs to her, to which, there are no rival claims nor any suit is pending. Hence, the petitioner prays this Court that the property may be measured and boundaries may be fixed accordingly.
