COMMON ORDER

These writ petitions have been filed praying for issuance of a Writ of Mandamus directing the 1st respondent to give electricity supply to the petitioners' houses in Thimmarajapuram, Palayamkottai Taluk, Tirunelveli District, without insisting NOC to be obtained from the second respondent.

2.When the matter is taken up for hearing, both the parties mutually consented upon to dispose of these writ petitions in similar to the order made in W.P.(MD)No.4944 of 2015 dated 15.04.2015.

3.Therefore, following the earlier order of this Court made in W.P.(MD)No.4944 of 2015 dated 15.04.2015, on the very same subject, these writ petitions are also disposed of, directing the petitioners to approach the first respondent with all the relevant documents, viz. Family Card, Nativity Certificate and copies of sale deeds as proof of purchase etc., and on receipt of such applications, the authority shall also issue notice to the second respondent and call for an enquiry and then pass appropriate orders, within a period of two months from the date of receipt of a copy of this order. The second respondent is also at liberty to produce the documents to substantiate their claim.

4.With the above direction, the writ petitions are disposed of. No costs.
