Pointing out certain errors committed in the UDR Register, with regard to measurement of the petitioner's land in S.No.58/3B, New S.No.232/7 in Manakarambai Village, Thiruvaiyaru Taluk, Thanjavur District, the petitioner has made a representation to the respondents dated 19.06.2015 seeking rectification of errors. The learned counsel for the petitioner seeks the indulgence of this Court for a direction to the second respondent to consider the representation of the petitioner and pass appropriate orders on merits.
