In view of the above, without going into the merits of the claim made by the petitioner in this Writ Petition, the first respondent is directed to pass appropriate orders on the representations of the petitioner, dated 12.06.2014 and 18.06.2015, in the light of G.O.Ms.No.137 (School Education) Department dated 09.06.2014, on merits and in accordance with law, after giving notice to the petitioner as well as the interested parties, if any, within a period of four weeks from the date of receipt of a copy of this order.

With the above direction, this Writ Petition stands disposed of. No costs.
