In view of the above limited prayer sought for in this Writ Petition, without going into the merits of the claim made by the petitioner in this Writ Petition, the first respondent is directed to dispose of the appeal of the petitioner dated 02.01.2014, on merits and in accordance with law, after giving notice to the interested parties, especially the second respondent herein, within a period of two months from the date of receipt of a copy of this order. The petitioner is directed to enclose a copy of this order along with the appeal dated 02.01.2014 for proper follow up by the first respondent.



With the above direction, this Writ Petition stands disposed of. No costs.
