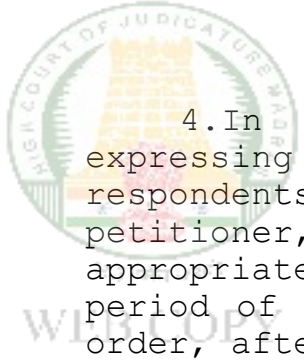

ORDER

3.The learned Counsel appearing on behalf of the petitioner submitted that it would suffice if the representation of the petitioner dated 03.07.2015 is disposed of, on merits and in accordance with law, within a time frame to be fixed by this Court.

In view of the limited scope of the prayer, without expressing any opinion on the merits of the issue involved, the respondents are directed to dispose of the representation of the petitioner, dated 03.07.2015, if not already disposed of, and pass appropriate orders on the same and in accordance with law, within a period of three months from the date of receipt of a copy of this order, after affording the petitioner an opportunity of being heard.

5. With the above direction, this Writ Petition stands disposed of. No costs.
