Till this date, such earned leave surrender salary has not been paid to the petitioner in spite of a representation having been made on 02.07.2014.



3.Considering the above stated facts and circumstances, the third respondent is directed to consider the representation of the petitioner dated 02.07.2014 and pass orders on the same on merits and in accordance with law within a period four weeks from the date of receipt of a copy of this order.
