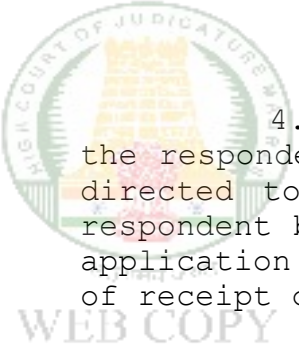

In this writ petition the petitioner is seeking for issuance of a Writ of mandamus directing the respondent NO.2 to provide the educational loan of Rs.84,000/- (Rupees eight four thousand only) for the academic year 2014 to 2017 for the petitioner's minor son P.Manoj to pursue Diploma Course in Mechanical Engineering and continue his further studies within the period that may be stipulated by this Court.

2. Heard the learned Counsel appearing for the petitioner and the learned counsel appearing for the respondents.

3. Today when the matter is taken up for hearing, the learned counsel for the respondent bank submitted that the bank officials are eagerly waiting for arrival of the petitioner for considering the petitioner's educational loan application and for passing orders as per IBI norms.
