3.The learned counsel for the petitioner in support of his submission to impress upon this Court that the enquiry officer has already completed the enquiry and submitted his report on 25.02.2015. Subsequently, the petitioner on receipt of show cause notice to submit his written representations, dated 10.04.2015 and 12.08.2015, but till date, the respondents have not pass any orders on the representations.

4.Considering the fact that the enquiry officer has already submitted his report, pursuant to that the petitioner also filed his written representations, this Court, directs the first respondent to complete the entire exercise, preferably within a period of eight weeks from the date of receipt of a copy of this order.

5. With the above direction, the writ petition is disposed of. No costs. Consequently, connected M.P(MD)No.1 of 2015 is also closed.
