The grievance of the petitioner appears to be that patta has been granted to ineligible persons. Since the said persons have not been made as party respondents in this writ petition, no direction as prayed for by the petitioner can be granted. However, the petitioner is directed to make a fresh representation to the competent authority giving all the details of the persons who have been alleged to be beneficiaries of illegal grant of patta. It is for the competent authority to consider the same on its own merit and in accordance with law.

2. With the above direction, the writ petition is disposed of. No costs. Consequently, M.P(MD)No.1 of 2014 is closed.
