ORDER

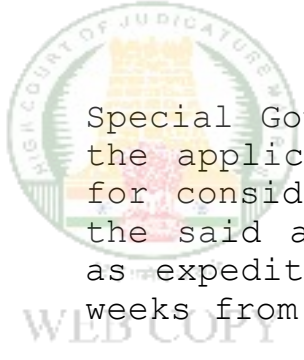
(Order of the Court was made by R.SUDHAKAR,J.)
