3. Considering the nature of the relief sought for by the petitioner, the authority concerned is directed to take action to remove the encroachment in accordance with the provisions of the Tamil Nadu Protection of Tanks and Eviction of Encroachment Act, 2007.

4. With the above direction, the writ petition is disposed of. No costs.
