PRAYER in WP(MD). 18114/ 2014: Writ Petition is filed under Article 226 of the Constitution of India for the issuance of a writ of Mandamus directing the second respondent not to interfere with the right of the petitioner to get signal service from MSO of his choice and consequently directing the second respondent not to compel the petitioner to get signal service from any other MSO except the third respondent MSO at Tiruchendur, Thoothukudi District.

Prayer in WP(MD). 19034 to 19036 & 20201/ 2014: Writ Petitions filed under Article 226 of the Constitution of India, praying to issue a writ of Mandamus directing the 2nd respondent not to interfere with the right of the petitioner to get signal service from any MSO of the petitioner's choice and consequently directing the 2nd respondent not to compel the petitioner to get signal service from any other private MSO by giving up the existing signal service connection from 3rd respondent Government MSO at Tirunelveli in doing his cable TV Business at

- i. Keelakadayam, Kadayam Post, Ambasamudram Taluk, Tirunelveli District.
- ii. Aladiyur, Ambasamudram Taluk, Tirunelveli District.
- iii. Cheranmahadevi, Ambasamudram Taluk, Tirunelveli District.
- iv. Veeravanallur, Ambasamudram Taluk, Tirunelveli District, respectively.

Prayer in WP(MD). 1285/ 2015: Writ Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Mandamus, directing the respondents 2 and 3 herein not to compel the petitioner herein to get signal service from any other private Taluk Cable Operator than to continue his choice of signal connection with existing Multi System Operator.
