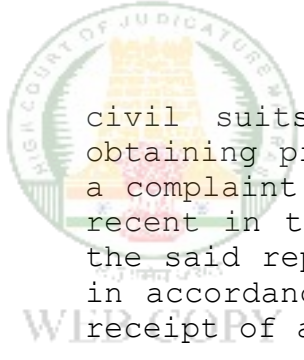

The grievance of the petitioner is that despite pendency of
