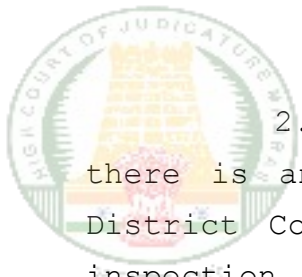

2. Normally, we expect the panchayat to act immediately, if there is any violation of law. Therefore, we only call upon the District Collector to instruct the revenue officials to cause an inspection on the basis of the letter issued by the Panchayat President and deal with the matter in accordance with law, so as to give quietus to the issue.

3. With the above observation, the writ petition is disposed of. No costs. Consequently, M.P(MD)No.1 of 2015 is closed.
