2. Pursuant to the said representation, the Additional Director of Panchayat, Thoothukudi, the second respondent has forwarded the same to the Block Development Officer, the fourth respondent herein directing him to disconnect the water connection, if there is any unauthorized connection.

3. In view of the above, the grievance of the petitioner has already been redressed by the second respondent. However, we expect the competent authority to pursue the matter to its logical conclusion. The writ petition is accordingly disposed of. No costs.
