In effect, no mandamus can be issued to implement the order already passed by this Court. In this case, the earlier orders on the issue are passed in W.P(MD)Nos.3586 of 2007, 14429 and 11558 of 2014. Therefore, we find no justification to entertain one more PIL on



the very same issue. However, it is always open to the petitioner to work his remedy in the manner known to law. Accordingly, the writ petition is dismissed. No costs.
