3. The petitioner seeks for a Mandamus directing the respondents to construct the shops and hand over two shops to the petitioner as he has become successful bidder in respect of such shops.

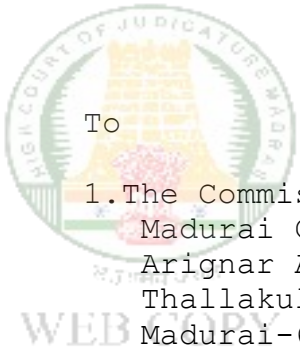
