ORDER

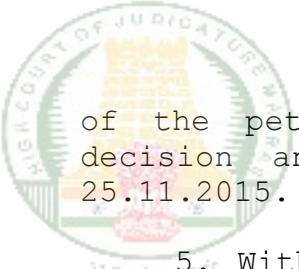
