<https://hcservices.ecourts.gov.in/hcservices/> The writ petition lies in a narrow compass. The petitioner was issued a charge memo by the fourth respondent as per the articles of charge in Ref.No.ZOK:Vig:CS:31514:2015-16 dated 31.08.2015. The



petitioner seeks for a direction to the fourth respondent to conclude the enquiry and pass final orders within the stipulated time as prescribed by this Court.

2.It is stated that though the petitioner gave an explanation dated 09.09.2015, an Enquiry Officer is yet to be appointed and no witnesses are examined. In the circumstances, direction is issued to the fourth respondent to pass final order in the disciplinary proceeding relating to the charge memo dated 31.08.2015, within a period of nine months from the date of receipt of a copy of this order.

3.With the above direction, this writ petition is disposed of. No costs. Consequently, the connected miscellaneous petition is closed.
