ORDER

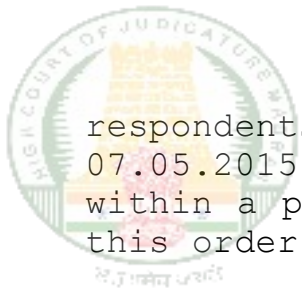
Mr.Sajibeno, learned counsel takes notice for the respondents. By consent, the Writ petition is taken up for final disposal at the admission stage itself.
