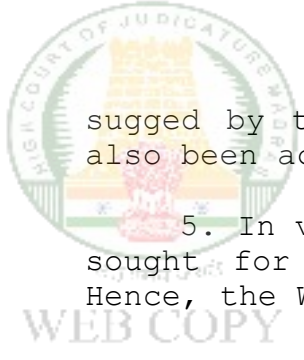
O R D E R

2. Heard the learned counsel appearing for the petitioner and the Additional Government Pleader appearing for the respondents.

In the last occasion i.e., on 14.12.2015, Mr.D.Muruganandham, Additional Government Pleader appearing for the respondent submitted that the place suggested by the petitioner's Association to stage Dharna (Aarpattam) near Palai Market Thidal, Tirunelveli, is not feasible and therefore, requested two days time for getting further instruction from the respondents.
