PRAYER IN W.P.(MD)No.22861 of 2015: Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents to consider the petitioner's representation dated 10.08.2015 and consequently, to survey petitioner's land by fixing the boundary in Survey Nos.77/1B, 77/1B3A, 79/9, 79/2B3A, 79/7 having an extent of 84 cents situated at Kurumpapatti Village, Dindigul North Taluk, Dindigul District and to issue individual patta to petitioner.

PRAYER IN W.P.(MD)No.22862 of 2015: Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents to consider the petitioner's representation dated 05.08.2015 and consequently, to survey petitioner's land by fixing the boundary in Survey Nos.1033/2, 748/9, 1025/1A2C, 1028/4, 1030, 1028/1, 814, 131, 132, 748/6A, 749/3 and 755/A having an extent of 2 acres 84 cents and to issue individual patta to petitioner which is situated at Sevagampatti Village, Nilakottai Taluk, Dindigul District.

PRAYER IN W.P.(MD)No.22863 of 2015: Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the respondents to consider the petitioner's representation dated 20.08.2015 and consequently, to survey petitioner's land by fixing the boundary in Survey Nos.79/6 having an extent of 23 ½ cents situated at Kurumpapatti Village, Dindigul North Taluk and to issue individual patta to the petitioner which is situated at Kurumpapatti Village, Dindigul North Taluk, Dindigul District.
