This writ petition has been filed in public interest, seeking a Writ of Mandamus to direct the respondents to remove the TASMAC shop No.10503 situated at Sempalani Village, Puthukudi Panchayat, Trichy - Chitamparam National Highways, Valadi Post, Lalgudi Taluk, Trichy District.

2. Heard both sides.

3. The grievance of the petitioner is that the representation dated 20.06.2013 submitted by the petitioner, has not been considered so far and hence, this writ petition.
