PRAYER: The Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records in connection with the impugned order dated 06.03.2015 passed by the 2nd respondent and quash the same as illegal, consequently, direct the respondents to grant permission to conduct Aadalum Paadalum cultural programme in Arul Migu Sri Mariamman Temple in Mugavur Village, Virudhunagar District on 07.04.2015.

O R D E R

(Order of this Court was made by **S.TAMILVANAN, J.**)

This Writ petition has been filed invoking Article 226 of the Constitution of India, seeking an order in the nature of Writ of Certiorarified Mandamus, calling for the records pursuant to the impugned order dated 06.03.2015 passed by the second respondent, quash the same as illegal, and consequently, direct the respondents to grant permission to conduct Aadalum Paadalum cultural programme in Arul Migu Sri Mariamman Temple in Mugavur Village, Virudhunagar District on 07.04.2015.

2.Heard the learned counsel appearing for the petitioner and the learned Special Government Pleader appearing for the respondents.

3.Learned counsel appearing for the petitioner would submit that Aadalum Paadalum cultural programme is being conducted by the villagers during the above said festival period. In this connection, a representation was given to the 2nd respondent, however, the same was rejected by the 2nd respondent and hence, the petitioner is before this



Court with this Writ petition. The learned counsel appearing for the petitioner further submitted that as the temple festival is celebrated in a peaceful manner by the villagers, there will be no untoward incident by the people of the village.

4.Mr.M.Alagathevan, learned Special Government Pleader appearing for the respondents, on instructions, would submit that the permission sought for by the petitioner may be granted with stringent conditions for maintaining law and order and also to avoid any untoward incident during performance of such programme.

5.Having considered the facts and circumstances and the submissions made by the learned counsel appearing for the petitioner and the learned Special Government Pleader appearing for the respondents, we are of the view that necessary permission shall be granted to the petitioner and his villagers to conduct Aadalum Paadalum cultural programme in the aforesaid Temple with reasonable conditions.

6.Accordingly, the Writ petition is disposed of with the following directions:

(a)The Aadalum Paadalum cultural programme in connection with Arul Migu Sri Mariamman Temple in Mugavur Village, Virudhunagar District be held on 07.04.2015 between 6.00 p.m. and 10.30 p.m.

(b)There should not be any kind of obscene dance or vulgar dialogues during the performance, by anyone of the participants;

(c)Double meaning songs should not be played so as to spoil the minds of students and the youth.

(d)No dance or songs, touching upon any political party or religion community or caste be played.

(e)No flex boards in support of any political party or religious leader be erected.

(f)The function should not affect either religious or communal harmony and shall be conducted without any discrimination based on caste.

(g)If there is any violation of any one of the conditions imposed, the concerned police officer is at liberty to take necessary action, as per law and stop such performance; and

(h)Similarly, the police is empowered to stop the dance programme, if it exceeds beyond the permitted time.

(i)The second respondent is directed to issue necessary permission, incorporating the above conditions.
