We have dealt with the appeals arisen from the order of the learned Single Judge which had failed to specify the period within which the retiral benefits were to be made available to the employees of the respondent Corporation. The said aspect stands settled with the statement taken on record made on behalf of the respondents Corporation as made by the learned Additional Advocate General.

2. The present petitions also relate to the same subject matter and thus, the order of the learned Single Judge, subject matter of appeal in those petitions in W.P.(MD) Nos.17319 of 2014 batch, as modified by an order passed in W.A.(MD)Nos.383 to 457 of 2015 equally apply to the present petitions and the present writ petitions are disposed of in terms thereof.

3. We clarify that these directions are applicable to Madurai Division, Kumbakonam Division and Coimbatore Divisions, as these petitions pertain to these three Districts.

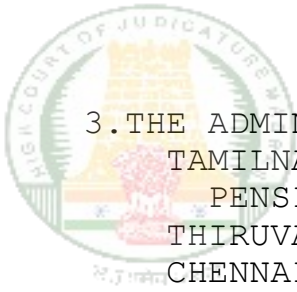
