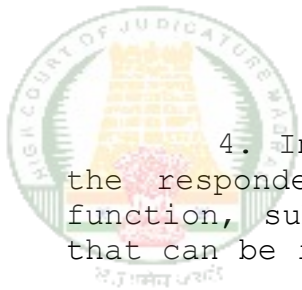

2. Heard the learned Counsel for the petitioner and the learned Additional Government Pleader, who takes notice for the respondents.

The matter is taken up for hearing, the learned Additional Government Pleader submitted that it has been resolved to permit the petitioner to conduct the function, in pursuant to the settlement arrived between the parties on 19.03.2014, subject to the condition that the petitioner should not use any arms and no "Mariyathai" is involved.
