**COMMON ORDER**

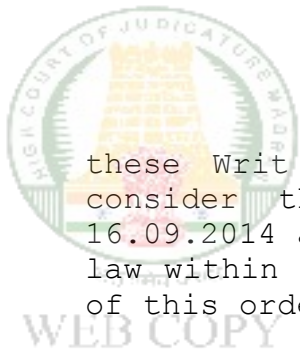
In all these cases, the petitioners are seeking for a direction to the respondents to grant old age pension to them.

3. The learned counsel appearing for the respondents submitted that the petitioners have already made individual representation before the first respondent, which may be directed to be considered on merits.
